Nov. 6, 2023 to Dec. 6, 2023 E-120 to E-90	Registrar of Voters / District	Between these dates, the Registrar of Voters will publish a Notice of Election containing the date of the election, the offices to be filled, where nomination papers are available and the deadline for filing Declarations of Candidacy. The notice may be combined with the notice of identifying the central county place.

Dec. 8, 2023 E-88	District	Last day to consolidate with General Election. Resolutions from districts calling a measure are due to the Registrar of Voters by December 8, 2023, 5:00 p.m . If you wish to have a full text printed in the Voter Information Guide, the Registrar of Voters must have the full text by December 8, 2023 . The statement of all measures submitted to the voters shall be abbreviated on the ballot and shall not contain more than 75 words. If applicable, all impartial analysis and fiscal impact statements are due by December 8, 2023, 5:00 p.m.

Dec 9-18, 2023 E-87 to E-78	Registrar of Voters	Public Review period for the measure, text, impartial analysis, direct arguments and fiscal impact statement, if applicable.

Dec. 11, 2023 E-85	Registrar of Voters	Registrar of Voters will assign measure letter designations to district to have measures on the ballot

File Arguments EC §9315, 9316, 9600			
Dec. 19, 2023 E-77	Proponent/Opponents	Last day set by the Registrar of Voters to submit arguments in favor or against the measure. Arguments may not exceed 300 words.	
File Rebuttals EC §9317, 9600			
Dec. 21, 2023 E-75	District	Last day set by the Registrar of Voters for the same authors of the primary argument to file rebuttals with the Registrar of Voters. Rebuttals are limited to 250 words.	
Public Review EC §9295			
Dec. 22, 2023 - Jan. 1, 2024 E-74 to E-64	Registrar of Voters	Public Review period for rebuttal arguments begins on December 22, 2023 and closes January 1, 2024 . Only Rebuttal Arguments are subject to legal action during this public review period.

March 5, 2024 E-Day	Registrar of Voters	Polls open at 7:00 a.m. and will close at 8:00 p.m. Vote-by-Mail ballots may be turned in before the polls close at any polling place in the jurisdiction.
